## HOMICIDAL DROWNING DEATH INVESTIGATION COURSE

POST control number: 2060-31444-16001

The Drowning Death Investigation Course is designed for Coroners, Medical Examiners and Law Enforcement Officers responsible for conducting investigations into drowning deaths. This three-day course will enhance the student's understanding of the unique investigation techniques specific to water-related incidents, how to prevent the loss of critical evidence and establish the appropriate mind-set to approach the scene for the successful investigation.

Topics Include: What Happens to Bodies and Other Evidence Underwater, The Drowning Scene, Witness Interviewing and Statement Analysis, Preservation of the Water-related Crime Scene. Handling and Retrieval of Submerged Evidence, Scene Profiling, and Homicide by Drowning Indicators. The course instruction includes practical exercises and scenarios.

*This is a 24-hour P.O.S.T. certified Plan IV course that complies with POST Regulation 1005(a) (5) (minimum training standard for peace officer coroners). Course meets the continuing professional education and training requirements for POST and ABMDI. Full attendance is necessary for course credit and POST reimbursement.
